I = [**Criminology Repository**: In addition to DigiKrimDok, the University Library and the Institute of Criminology are about to collect books, brochures and other documents belonging to the so-called “Gray Literature”. The main languages so far are German and English. As of August 2020, some 1,500 documents have been stored. Most documents are PDFs. Access and Download are free of charge]³

II = [**KrimDok**: Electronic database, providing bibliographic information on publications of all sorts on Criminology etc., mainly in German and English, containing at present some 250,000 entries. KrimDok offers different search options⁴
